



MEMBERSHIP APPLICATION

Classes of membership are defined as:

Corporate Membership

An organisation that is engaged in competitive Construction Diving work as their core business. These members are able to vote at all meetings of the Society and are deemed competent to be elected to the committee. Voting rights of each corporate entity shall be restricted to one.

Ordinary Membership

An individual OSH Certified construction diver not engaged in competitive business activity with Members of the Association. Voting rights are restricted to their representative elected at the annual general meeting. There are two ordinary members elected to represent them on the committee.

Associate Membership

Are any persons who are suppliers of specialised goods or services, or persons who may have a vested interest in the diving industry. Associate members are not eligible to vote at any meetings of the Society although their views are considered.

Membership Fees

Joining Fees

All classes of membership are required to pay a one-off joining fee which is payable upon acceptance to the Society.

Annual Subscription

All classes of membership are required to pay an annual subscription fee in advance, expiring the following July. The first subscription fee will be invoiced upon acceptance to the Society together with the Joining Fee.
